## Commitment to achieving Net Zero

Precisis GmbH is committed to achieving Net Zero emissions by 2050.

## Baseline Emissions Footprint

<b>Additional Details relating to the Baseline Emissions calculations.</b>	
In the baseline year, 2019, Precisis had 11 employees and was using 1 company car. Most of the employees commuted by public transportation or bicycle.	
For the current year, 2022, Precisis had 21 employees and was using 2 company cars. Precisis is offering a hybrid working model. Employees coming into the office are still favouring public transportation and bike.

## Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 45 tCO<sub>2</sub>e by 2028. This is a reduction of 12%

## Carbon Reduction Projects

### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2019 baseline.

Until March 2023, the Precisis headquarters were located in an old building in Heidelberg's old town. Since our last emission reporting, we have moved into a more modern office space with better insulation, reducing heating. The building also provides the majority of its electricity from solar panels on the roof and is equipped with parking for electric vehicles.

Furthermore, for domestic business travel the use of trains is highly encouraged over the use of planes and videocalls replace physical travel wherever possible.

Since the pandemic, Precisis has offered its employees a hybrid working model and is upholding this offer to date.

The carbon emission reduction achieved by moving office will only be visible in the next reporting. Renunciating domestic flights equated to a reduction of 6 tCO<sub>2</sub>e. The measures will be in effect when performing the contract.

Assessment of supplier's carbon footprint is underway. Precisis plans to find agreements on reduction in the following years.

In the future we hope to implement further measures such as:

Changeover completely to green electricity = minus 2.6 tons

Exchange of diesel for electric vehicle and charging with green electricity = minus 2.5 tons

## Declaration and Sign Off
